Employers of foreign domestic workers with existing private insurance coverage are exempted from contributions only up to 31 May 2022. This is in line with the governments granting of a one-year cooling period since the new ruling came into effect on 1 June 2021 (Source: SOCSO ). After 31 May 2022, all employers must register and contribute through SOCSO by 1 June 2022 even if their workers existing policy only expires after 31 May 2022. Important Note for Malaysian Employers of Filipino Domestic Helpers: Starting January 2022, Malaysian employers of Filipino domestic helpers are required to register and contribute to SOCSO as the Philippine Overseas Labour Office (POLO) in Kuala Lumpur has released an advisory making it mandatory for all Malaysian employers to present SOCSO registration and contribution proof for any POEA contract verifications/ renewal transactions from 2 January 2022 onwards (Source: POLO ).

## Download Borang Socso 8a

The Social Security Organisation (SOCSO) is a Malaysian government agency that was mandated to provide social security protections to employees in the private sector. The Ministry of Manpower regulates and certifies the number of foreign workers needed in the private sector and are still in demand. As a Malaysian employer of a foreign domestic worker, the SOCSO has the responsibility of providing social security protections to your workers for as long as the period of employment. As of 1 June 2021, all employers of foreign domestic workers are required to register and make monthly contributions to the SOCSO for all employees in accordance with the Employee Welfare Act 1969. The employer and his employees must be registered with the SOCSO no later than 30 days after the Law becomes applicable in the industry. To register, an employer must complete the Employer Registration Form, Borang 8A Report, along with the specified relevant documents. The SOCSO will be notified of any changes in name, address, type of ownership, employer or employee status. SOCSO has extended social security protection coverage of domestic workers in the private sector until June 30, 2021 at the current rate of RM50 per month, for all such workers irrespective of an employers level of contribution effective 1 June 2021. For employers, this means any foreign worker that is employed within the Malaysian labour force and is not covered by any social security scheme. There is a special treatment to the foreign domestic workers who are employed in the private sector to care for Malaysian elderly or persons with a disability. Specifically, this means that all foreign domestic workers irrespective of when they started working in the private sector will be eligible to receive social security payment since 1 June 2021. For those foreign domestic workers who are employed in the private sector, SOCSO should be notified of any changes in name, address, type of ownership, employer or employee status. 5ec8ef588b
